This will help slow entry attempts and allow controlled access through gates or designated entry points.
06	Neighborhood and Space Analysis	The objective is to evaluate current and/or planned perimeter protection measures to define a clear boundary around the property, deter unauthorized access, and offer a visual deterrent to potential intruders. This will help slow down entry attempts and enable controlled access through gates or designated entry points.
07	Building Design Physical Security Analysis	The goal is to assess the building's architectural design to identify potential vulnerabilities and weaknesses, helping to clarify factors that could either support or hinder security measures. It also aims to identify any challenges that may arise during the installation of security systems.
